THINKLABS LIMITED WARRANTY

Subject to the exclusions contained below, Thinklabs Medical LLC ("Thinklabs") warranty obligations for this hardware product are limited to the terms set forth herein: Thinklabs warrants the Covered Product, as defined below, against defects in materials and workmanship under normal use for a period of TWO (2) YEARS from the date of retail purchase by the original purchaser ("Warranty Period").

If a manufacturing defect arises and a valid claim, following Thinklabs' Return Procedure, is received by Thinklabs within the Warranty Period, at its option and to the extent permitted by law, Thinklabs will either (1) repair the product at no charge, using new parts or refurbished parts that are equivalent to new in performance and reliability, (2) exchange the product with a product that is new or refurbished that is equivalent to new in performance and reliability and is at least functionally equivalent to the original product, or (3) refund the purchase price of the product.
